**PARK RULES**

1. Park hours are 6:00 am to dusk. All vehicles and persons are to be off park property at such time unless prior approval is obtained. Vehicles left after hours without permission will be towed at the owner's expense.
2. Grills should be emptied before leaving. Hot coal should not be thrown into the garbage cans.
3. No overnight camping or tenting is permitted.
4. No open fires or burning or fireworks are allowed.
5. No firearms or archery equipment is permitted.
6. No dogs allowed.
7. Garbage is to be removed and placed into containers provided. If you bring it in, please clean it up.
8. No alcoholic beverages are permitted on park property.
9. Parking is permitted only in designated lots. **No motorized** vehicles are allowed in any other area. They will be towed at the owner's expense.
10. No vandalism or destruction of park property is allowed. Vandalism constitutes a misdemeanor and violators will be prosecuted under state law, which has a penalty up to a \$1,000.00 fine in addition to reimbursement for the damaged items.
11. Picnic tables are to be returned to the shelter prior to leaving.
12. Violation of any of these rules or any other laws of the State of Indiana will result in immediate removal from park property and loss of fees and possible criminal prosecution.
